Detailed description of the key rating drivers

CARE Ratings Nepal Limited (CRNL) has withdrawn the ratings of "CARE-NP B; ISSUER NOT COOPERATING*", "CARE-NP A4; ISSUER NOT COOPERATING*" and "CARE-NP B/A4; ISSUER NOT COOPERATING*" assigned to the bank facilities of Divya Jyoti Construction Private Limited (DJCPL) with immediate effect as DJCPL had failed to provide information for monitoring of the ratings. In line with the extant of Securities Board of Nepal (SEBON) guidelines, CRNL has reviewed the rating on the basis of the best available information and kept the rating on Notice of Withdrawal for six months which however, in CRNL's opinion is not sufficient to arrive at a fair rating. Therefore, after the monitoring of the ratings for six months there is no cooperation from the Issuer, accordingly CRNL has withdrawn the ratings.

Users of this ratings (including investors, lenders and the public at large) are hence requested to exercise caution while using the above ratings.

Divya Jyoti Construction Private Limited (DJCL) was incorporated in 2014 and took over the business Bandhu Nirman Sewa which was established in 1993. DJCL is a "C" class construction company with registered office based in Neelkantha-03, Dhading. The company is mainly involved in construction of road, bridge, civil & hydro mechanical, irrigation, water supply & sanitation, etc. DJCL also enters into Joint Ventures (JVs) with other companies in order to meet the eligibility criteria for different construction projects.
