CARE Ratings Nepal Limited (CRNL) has been seeking information from Saptakoshi Cement Private Limited (SCPL) to monitor the ratings vide e-mail communications/ letters dated July 26, 2023, July 19, 2023, and July 03, 2023 along with numerous phone calls. However, despite our repeated requests, the company has not provided the requisite information for monitoring the ratings. In line with the extant Securities Board of Nepal (SEBON) guidelines, CRNL has reviewed the rating on the basis of the best available information which however, in CRNL's opinion is not sufficient to arrive at a fair rating. CRNL will monitor/watch the rating once for a minimum period of 6 months and notify the Securities Board of Nepal (SEBON) and public with regards to the withdrawal of rating. If after the monitoring of the rating there is no cooperation from the Client, then after, CRNL may withdraw the rating.

The bank loan rating of Saptakoshi Cement Private Limited will now be denoted as **CARE-NP BB/ CARE-NP A4: ISSUER NOT COOPERATING***, (Notice of withdrawal).

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating.

Detailed description of the key rating drivers

The ratings have been revised taking into account non-cooperation by SCPL with CARE'S efforts to undertake a review of the rating outstanding. CARE views information availability risk as a key factor in its assessment of credit risk.

Saptakoshi Cement Private Limited (SCPL) is a private limited company which was incorporated on April 22, 1996. The name of the company was changed from National Cement Private Limited to Saptakoshi Cement Private Limited three years ago. SCPL is a closed-circuit grinding plant located in Kathari-4, Biratnagar, Morang, Nepal with an installed capacity of 600 TPD

for OPC Cement. The plant has two units- Unit -1 of 100 TPD and Unit 2 of 500 TPD which commenced commercial operation from December 2018 onwards.
